All native fauna held in care by the NATF Inc. members is subject to National Parks Wildlife Service NSW licence MWL0001 00266. Members who wish to become involved in the care and rehabilitation of native fauna are required to undertake approved training and have facilities approved before the appropriate authority may be issued. <i>*Persons under 18 years are not permitted to rescue and rehabilitate native fauna.</i> The Management Committee shall have the right to refuse membership to any applicant or may refuse to renew any membership. In no case shall the Committee be required to give any reasons for the rejection of the application. I hereby agree to abide by the terms and conditions of the Constitution of the Native Animal Trust Fund Inc and if authorised as a Rescuer/Rehabilitator, to meet the conditions contained in the General Licence MWL0001 00266 and Rescuer/Rehabilitator Policy of the NATF Inc.
