## Nominations

The current Management Committee is now calling for nominations for the following positions:

- **Executive Committee (1 position)**
- **President**
- **Vice President**
- **Treasurer**
- **Secretary**
- **General Committee representatives (up to 5 positions)**

### Nominations Process:

1. Members may nominate for as many different positions as listed; however, no member can nominate more candidates than the number being elected.
  2. Any member may be nominated for more than one executive committee position but may not hold office in more than one executive committee position.
  3. A member may hold a committee position and/or multiple portfolio /Species Coordinators positions.
  4. A member may nominate themselves.
  5. Each nominee shall have a seconder, and the nominee must have consented to the nomination.
  6. A 200-500 word appraisal should accompany the nomination and will be sent to the membership should voting be required.
  7. Nominations must be in writing, signed by the nominator and must be accompanied by the written signed consent of the candidate. Both members must be current finical members. Candidate consent can count as one of the two required signatures and can be a separate email to the nomination form.
  8. Signed documentation includes e-correspondence from a members registered email address. You may use the attached nomination form or similar, be sure to include:
    - a) Position for which the member is being nominated
    - b) Full name and contact number of member being nominated
    - c) Full name, contact number and signature of nominator;
    - d) Full name and contact number of person seconding the nomination and signature;
    - and e) Written signed consent of the nominee (may be received by the Secretary in a separate email)
- As per the Hunter Wildlife Rescue (NATF Inc.) Constitution, "All nominations must be received by the secretary". Election of Committee Members as per the Hunter Wildlife Rescue (NATF Inc.) Constitution:
- (ii) If insufficient nominations are received to fill all vacancies on the committee, the candidates nominated are taken to be elected and further nominations are to be received at the annual general meeting.

(iii) If insufficient further nominations are received for the minimum number of committee members, any vacant positions remaining on the committee are taken to be casual vacancies. (iv) If the number of nominations received is equal to the number of vacancies to be filled, the persons nominated are taken to be elected

(v) If the number of nominations received exceeds the number of vacancies to be filled, a ballot is to be held.

(vi) The ballot for the election of office-bearers and ordinary committee members of the committee is to be conducted at the annual general meeting in such usual and proper manner as the committee may direct.

(vii) A person nominated as a candidate for election as an office-bearer or as an ordinary committee member of the association must be a member of the association  
Close of Nominations: Nominations shall be accepted up to 5.00pm, Saturday the 7<sup>th</sup> of June 2025.
